**POLICIES AND PROCEDURES
FOR USE OF**

Grizzly Flats Community Church Facilities

- A. All organizations or residents granted permission to use Grizzly Flats Community Church facilities will assume the responsibility for the loss of any object or objects that are damaged or destroyed as a result of the activities engaged in by the organization or any patron in attendance. ***It is strongly recommended that organizations obtain adequate insurance for self protection.***
- B. Grizzly Flats Community Church and its employees, Elders, Deacons, Officers, and congregation members shall not be responsible for damage to or loss of property sustained by the applicant, participant in a program or patron of any program held in a Grizzly Flats Community Church facility.
- C. All applications are subject to cancellation, with or without due notice, for any reason whatsoever.
- D. Applicant must be present at all times during the rental period and/or until all participants have vacated the premises.
- E. Adequate supervision must be provided by the applicant for any event at which minors will be present.
- F. Only furniture or equipment specifically approved in the application shall be used by the applicant.
- G. Provisions for any special equipment or decorations must be made in advance.
- H. Requested Donation: **Non-Profit organizations**, as well as both members and non-members not requiring a facility fee will be responsible for a \$35.00 Janitorial fee (due at least two weeks prior to the event). All other organizations not meeting the above criteria (excluding weddings) will be subject to a fee of \$110.00. **Fees for Weddings: Fees for Members** will be \$195.00 which includes a \$50.00 refundable deposit: (*These fees may be waived at the discretion of a Pastor or Church Board*) this deposit can be forfeited based on the condition of the facility after use. **Requested Donations for Non-Members** will be \$270.00 which includes a \$50.00 refundable deposit: this deposit can be forfeited based on the condition of the facility after use. Consumption of alcoholic beverages will not be permitted on the premises.
- I. In case of snow or inclement weather, Grizzly Flats Community Church will not be clearing or sweeping the parking lot or pathways.
- J. The User or Organization will be responsible for any damages to the Church Facilities while in their use (when deemed appropriate).
- K. The use of Church Audio/Visual equipment and Computer/Presentation hardware/software must be pre-approved.
- L. A one-year limit will exist for a contract for use of the Church Facilities by a User or Organization. If a request for renewal is submitted, such request will be treated as any new application.
- M. Rooms must be left in a neat and orderly manner when finished with the activity. Any extra cleaning needing to be done by Grizzly Flats Community Church will be billed directly to the applicant at a rate of \$25.00 an hour.
